Subject: Blacklisting of M/s Immence Technologies on account of irregularities found in the computers provided by the firm in the M/o I&B -reg.

Sir,

I am directed to refer to this Ministry's work order dated 03.11.2015 vide which Ministry had placed order with M/s Hewlett Packard India Sales Pvt. Ltd. for providing 35 computer (desktops) having Intel core i7 on DGS&D Rate Contract. In response to this Ministry's work order, M/s Hewlett Packard India Sales Pvt. Ltd. had authorized your firm M/s Immence e Technologies Pvt. Ltd. as HP Authorized Partner for early fulfilment of the requirements vide their letter dated 06.11.2015.

2. Subsequently, a work order dated 19.11.2015 was issued to your firm M/s Immence e Technologies Pvt. Ltd. by the Ministry for the aforesaid 35 computer (desktops) having Intel core i7 on DGS&D Rate Contract against which your firm had provided 35 computers in the Ministry and payment was made to your firm against the order. Thereafter, a complaint has been received in the Ministry alleging that your firm has provided Dual Core computers in place of Core i7 which was ordered by the Ministry.

3. Accordingly, to check the veracity of the complaint, specification of the 35 computes provided by your firm were checked. It came to light that the allegations made in the complaint were true and that all the 35 computers provided by your firm against the aforementioned order by the Ministry are core i3/ Pentium in place of core i7 which were ordered and payment was made.

4. Annual Maintenance Contract (AMC) in respect of Computers and peripherals etc. is also being provided by your firm M/s Immence e Technologies Pvt. Ltd. in this Ministry. Since, the charges against the firm M/s Immence Technologies are of very serious nature hence, the AMC with your firm stands terminated with immediate effect and as per rule 151 of GFR-2017, the firm **M/s Immence e Technologies Pvt. Ltd. is debarred from participating in future tenders/NITS of Ministry of Information and Broadcasting and from carrying out any maintenance services/provision of computer items in this Ministry with immediate effect.**
