

## FUNCTION OF THE COMMITTEE

The function of the Committee will be to review the position and tender advice in regard to progressive use of Hindi for official purpose in the Ministry of Information and Broadcasting and its Attached/Subordinate Offices/Corporations/Boards/Media units etc. in accordance with the policies laid down by the Kendriya Hindi Samiti and the Department of Official Language (Ministry of Home Affairs) on the subject.

## TENURE

The tenure of members of the Committee will ordinarily be three years from the date of constitution of the Committee provided:-

1. Members of the Parliament, who are members of the Committee, shall cease to be Members of the Committee as soon as they cease to be Members of the Parliament.
2. The ex-officio members of the Committee shall continue members so long as they hold office by virtue of which they are members of the Committee and
3. If a vacancy arises in the Committee due to resignation or death of a member, the appointee to that vacancy shall hold office for the residual period of the tenure of three years.

## GENERAL

1. The Headquarter of the Committee shall be at New Delhi but it may hold its meeting at any other place also.
2. Non-Official members of the Committee will be paid travelling allowance and daily allowance for attending the meeting of the Committee at the rates prescribed as per O.M. No. II/20034/4/86-O.L.(A-2) dated 22.1.1987 of Department of Official Language and in accordance with the prescribed rates and rules as amended from time to time by the Government of India.
